Notes/Narratives

On Wednesday September 16th, 2015 at approximately 0700 hours a destruction board for firearms convened in the firearms unit located at 945 E Ohio (EPIC). The board consisted of Lt. Eric Johnson #40360, Sgt. Gary Parrish #35800, Det. Greg Wright #19980 and Evidence Technician Nickie Perger #37166. The board verified the firearms on the attached lists. At approximately 0930 hrs HVF West advised that their machine was not functioning and a part had to be ordered. The part would not be delivered until Monday September 21st. They advised the earliest they would be able to conduct the disposal was Thursday September 24th. The board then transferred the audited firearms to a cage in the marijuana unit. The firearms were secured in the cage with a yellow tag that contained the unique #100902. Lt. Johnson and Evidence Technician Nickie Perger notated the number of the tag and the board was dismissed.

On Wednesday September 30, 2015 at approximately 0800 hours the firearms board reconvened. Lt. Johnson and Evidence Technician Nickie Perger verified the number on the yellow tag. After the verification the tag was cut and the firearms were loaded onto the box truck. At approximately 0815 hours the board, escorted by SWAT personnel, transported the weapons to HVF West where 264 firearms were destroyed. NFI





- 100% of the firearms scheduled for destruction shall be physically compared against the destruction records and each serial number shall be verified against the firearm.
- Any items that do not match the recorded serial number shall be pulled from the audit and the Evidence Superintendent shall be notified.
- All board members shall remain through the entire audit, transfer and/or destruction. If the firearms are crushed, board members shall witness the physical destruction and shall verify all weapons have been dismantled in a method that renders the firearm completely inoperable.
- If the destruction carries over into an additional day, the Lieutenant in charge shall be responsible for the key to the destruction cages. No other member of the board or property team shall have access to the items locked inside the cages, until the Lieutenant is present. Once the Lieutenant has confirmed the destruction is complete, the key shall be turned back over to Property & Evidence.

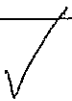

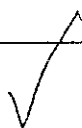
