NOTICE OF VIOLATION

The Arizona Secretary of State's Office has found reasonable cause to believe that the Barry Goldwater Institute for Public Policy Research ("Goldwater Institute"), ID #106605, failed to register Goldwater Institute employees Jon Riches and Christina Sandefur as lobbyists as required by A.R.S. § 41-1232; On February 17, 2020 and February 20, 2020, Mr. Riches and Ms. Sandefur respectively, appeared before the Arizona State Legislature and advocated the position of Goldwater Institute on pending legislation.

Under state law, a respondent served with an order requiring compliance with A.R.S. § 41-1232 has "twenty days from the date of issuance of the order" in which the respondent

may either comply or request a hearing pursuant to the Uniform Administrative Hearing Procedures in A.R.S. § 41-1092 *et seq. See* A.R.S. § 41-1237.01(A). On August 23, 2020, the Goldwater Institute amended its registration statement with the Arizona Secretary of State by adding Jon Riches and Christina Sandefur as authorized lobbyists for the Goldwater Institute. In light of the Goldwater Institute's corrective action, the Office will not issue a final order assessing a civil penalty as provided in A.R.S. § 41-1237.01.
