**MOTION TO DISMISS WITHOUT  
PREJUDICE**

(Assigned to the Hon. Bruce Cohen)

The State of Arizona moves to dismiss the pending charges against Jenna Ellis, in CR2024-006850-015 pursuant to Rule 16.4(a). Ellis has entered a cooperation agreement with the State of Arizona. If Ellis fails to comply with the terms of her agreement, she has agreed to waive a preliminary hearing, and waive any argument under the statute of limitations, if the State determines charges should be re-filed. The cooperation agreement and supporting documents are attached to this motion.

This is also in the interest of justice as Ellis has already entered into a plea agreement for a felony conviction in Georgia, arising out of the same conspiracy charged in this case. Accordingly, the State moves to dismiss the pending charges against Ellis without prejudice.
