### Victims' Rights Education and Outreach

The Arizona Attorney General's Office is dedicated to a system of justice that is inclusive of crime victims and will remain focused in striving to provide the most efficient and effective services to the people of Arizona. The Office of Victim Services (OVS) is a service-oriented Section within the Criminal Division of the Attorney General's Office. OVS programs exist for both the direct benefit of crime victims and the many state and local governmental entities in Arizona who serve them. The OVS Victims' Rights Outreach and Education Program conduct presentations statewide on victims' rights laws and provision of services to victims of crime. The presentations have been developed to set the stage for an effective approach to achieving the statutory intent of victims' rights in an effort to expand delivery and improve the quality of victims' rights services.

**Basic Victims' Rights** is suggested for employees new to victims' rights OR for anyone who needs a refresher. Because the curriculum is regularly updated and victims' rights can be complicated, we recommend (and VOCA requires) that those serving victims attend Basic at least once every five years. The content covers fundamental information about victims' rights for victims of a criminal offense or delinquent act and includes: a brief history of victims' rights; definitions; a victim's journey through the criminal and juvenile justice system; pre and post-conviction/adjudication; and information on restitution. Basic Victims' Rights is a five-hour presentation and is scheduled from 9:00AM- 3:00PM.

Advanced Victims' Rights is intended for experienced victim services providers, such as those who have completed our Basic session and anyone interested in gaining a greater understanding of victims' rights. Annual attendance is recommended for Advanced since the subject matter changes from year to year and the attendee will receive up to date information on statutory changes. This year's topic is interactive and simulates an adult felony case moving through the criminal justice system as experienced by the victim, along with a video featuring three victims and their experience going through the criminal justice system. A legislative update will be provided as well. Advanced Victims' Rights is presented in a three hour session and is usually scheduled from 9:00AM – 12:00PM.

### Basic and Advanced Victims' Rights courses are approved for the following types of credit:

- Arizona Peace Officer Standards & Training (AZ POST)
- Committee on Judicial Education and Training (COJET)
- VOCA
  - Courses may qualify for Continuing Legal Education (CLE) credit.
