**CHARGING VIOLATIONS OF:**

**COUNTS 1-5: SEXUAL  
EXPLOITATION OF A MINOR**, Class 2  
Felonies and Dangerous Crimes Against  
Children, in violation of A.R.S. § 13-3553;

**COUNTS 6 & 10: MOLESTATION OF A  
CHILD**, Class 2 Felonies and Dangerous  
Crimes Against Children, in violation of  
A.R.S. § 13-1410;

**COUNTS 7-9: SEXUAL CONDUCT  
WITH A MINOR**, Class 2 Felonies and  
Dangerous Crimes Against Children, in  
violation of A.R.S. § 13-1405.

The Arizona State Grand Jury accuses, **KERI ANN HARWOOD**, charging on  
this 21<sup>st</sup> day of August, 2017, that in or from Maricopa County, Arizona:

**COUNT 1**  
**SEXUAL EXPLOITATION OF A MINOR**

On or between May 1, 2017 and August 13, 2017, **KERI ANN HARWOOD**, knowingly distributed, transported, exhibited, received, sold, purchased, electronically transmitted, possessed, or exchanged a visual depiction, **DSC\_5260.MOV**, in which a minor under fifteen years of age is engaged in exploitive exhibition or other sexual conduct, in violation of A.R.S. §§ 13-3821, 13-3551, 13-3553, 13-705, 13-702, 13-701, and 13-801.

**COUNT 2**  
**SEXUAL EXPLOITATION OF A MINOR**

On or between May 1, 2017 and August 13, 2017, **KERI ANN HARWOOD**, knowingly distributed, transported, exhibited, received, sold, purchased, electronically transmitted, possessed, or exchanged a visual depiction, **DSC\_5264.MOV**, in which a minor under fifteen years of age is engaged in exploitive exhibition or other sexual conduct, in violation of A.R.S. §§ 13-3821, 13-3551, 13-3553, 13-705, 13-702, 13-701, and 13-801.

**COUNT 3**  
**SEXUAL EXPLOITATION OF A MINOR**

On or between May 1, 2017 and August 13, 2017, **KERI ANN HARWOOD**, knowingly distributed, transported, exhibited, received, sold, purchased, electronically transmitted, possessed, or exchanged a visual depiction, **DSC\_5265.MOV**, in which a minor under fifteen years of age is engaged in exploitive exhibition or other sexual conduct, in violation of A.R.S. §§ 13-3821, 13-3551, 13-3553, 13-705, 13-702, 13-701, and 13-801.

**COUNT 4**  
**SEXUAL EXPLOITATION OF A MINOR**

On or between May 1, 2017 and August 13, 2017, **KERI ANN HARWOOD**, knowingly distributed, transported, exhibited, received, sold, purchased, electronically transmitted, possessed, or exchanged a visual depiction, **DSC\_5268.MOV**, in which a minor under fifteen years of age is engaged in exploitive exhibition or other sexual conduct, in violation of A.R.S. §§ 13-3821, 13-3551, 13-3553, 13-705, 13-702, 13-701, and 13-801.

**COUNT 5**  
**SEXUAL EXPLOITATION OF A MINOR**

On or between May 1, 2017 and August 13, 2017, **KERI ANN HARWOOD**, knowingly distributed, transported, exhibited, received, sold, purchased, electronically transmitted, possessed, or exchanged a visual depiction, **DSC\_5272.MOV**, in which a minor under fifteen years of age is engaged in exploitive exhibition or other sexual conduct, in violation of A.R.S. §§ 13-3821, 13-3551, 13-3553, 13-705, 13-702, 13-701, and 13-801.

**COUNT 6**  
**MOLESTATION OF A CHILD**

On or between May 1, 2017 and August 13, 2017, **KERI ANN HARWOOD**, intentionally or knowingly engaged in or caused a person to engage in sexual contact, with, **VICTIM 1**, a child, who is under fifteen years of age, **TO WIT**: Incident in **DSC\_5260.MOV** where the defendant rubbed the victim's anus, in violation of A.R.S. §§13-1410, 13-610, 13-1401, 13-3821, 13-701, 13-702, 13-705, and 13-801.

**COUNT 7**  
**SEXUAL CONDUCT WITH A MINOR**

On or between May 1, 2017 and August 13, 2017, **KERI ANN HARWOOD**, intentionally or knowingly engaged in sexual intercourse or oral sexual contact with VICTIM 2, who was a minor under the age of fifteen years, TO WIT: Incident in DSC\_5264.MOV where the defendant rubbed the victim's penis, in violation of A.R.S. §§ 13-1401, 13-1405, 13-3821, 13-610, 13-705, 13-701, 13-702, and 13-801.

**COUNT 8**  
**SEXUAL CONDUCT WITH A MINOR**

On or between May 1, 2017 and August 13, 2017, **KERI ANN HARWOOD**, intentionally or knowingly engaged in sexual intercourse or oral sexual contact with VICTIM 2, who was a minor under the age of fifteen years, TO WIT: Incident in DSC\_5265.MOV where the defendant rubbed the victim's penis, in violation of A.R.S. §§ 13-1401, 13-1405, 13-3821, 13-610, 13-705, 13-701, 13-702, and 13-801.

**COUNT 9**  
**SEXUAL CONDUCT WITH A MINOR**

On or between May 1, 2017 and August 13, 2017, **KERI ANN HARWOOD**, intentionally or knowingly engaged in sexual intercourse or oral sexual contact with VICTIM 2, who was a minor under the age of fifteen years, TO WIT: Incident in DSC\_5268.MOV where the defendant rubbed the victim's penis, in violation of A.R.S. §§ 13-1401, 13-1405, 13-3821, 13-610, 13-705, 13-701, 13-702, and 13-801.

**MOLESTATION OF A CHILD**


On or between May 1, 2017 and August 13, 2017, **KERI ANN HARWOOD**, intentionally or knowingly engaged in or caused a person to engage in sexual contact, with, **VICTIM 1**, a child, who is under fifteen years of age, TO WIT: Incident in DSC\_5272.MOV where the defendant rubbed the victim's anus, in violation of A.R.S. §§13-1410, 13-610, 13-1401, 13-3821, 13-701, 13-702, 13-705, and 13-801.
