On or between December 12, 2016 and April 19, 2017, **REYNALDO GRANADO**, knowingly distributed, transported, exhibited, received, sold, purchased, electronically transmitted, possessed, or exchanged a visual depiction,

**SEXUAL EXPLOITATION OF A MINOR**

On or between December 12, 2016 and April 19, 2017, **REYNALDO GRANADO**, knowingly distributed, transported, exhibited, received, sold, purchased, electronically transmitted, possessed, or exchanged a visual depiction, 2e3b5e49-49d5-

43da-a99b-a09bb61a3c93 mp4, in which a minor under fifteen years of age is engaged in exploitive exhibition or other sexual conduct, in violation of A.R.S. §§ 13-3821, 13-3551, 13-3553, 13-705, 13-702, and 13-801

**COUNT 11**  
**TAMPERING WITH PHYSICAL EVIDENCE**


On or about April 19, 2017, **REYNALDO GRANADO**, destroyed, mutilated, altered, concealed, or removed physical evidence with the intent to impair its verity or availability with the intent that such physical evidence be used, introduced, rejected or unavailable in an official proceeding which was pending or which **REYNALDO GRANADO** knew was about to be instituted, in violation of A.R.S. §§ 13-2801, 13-2809, 13-701, 13-702, and 13-801


Pursuant to A.R.S. § 21-425, the State Grand Jurors find that the offenses described above were committed in Maricopa County, Arizona.
