INDICTMENT

CHARGING VIOLATIONS OF:

COUNT 1: FRAUDULENT SCHEMES & ARTIFICES, a Class 2 Felony, in violation of A.R.S. § 13-2310

COUNT 2: THEFT, a Class 2 Felony, in violation of A.R.S. § 13-1802(A)(2)

COUNTS 3-5: THEFT, a Class 1 Misdemeanor, in violation of A.R.S. § 13-1802(A)(3)

The State Grand Jury accuses **JON PAUL MECK**, charging on this 13th day of February, 2019, that in or from Maricopa County, Arizona:

COUNT 1:
FRAUDULENT SCHEMES & ARTIFICES

On or between February 1, 2012 and July 31, 2018, **JON PAUL MECK**, pursuant to a scheme or artifice to defraud, knowingly obtained a benefit by means of false or fraudulent pretenses, representation, promises, or material omissions, in violation of A.R.S. §§ 13-2310, 13-701, 13-702 and 13-801.

COUNT 2:
THEFT

On or between February 1, 2012 and July 31, 2018, **JON PAUL MECK**, without lawful authority, knowingly converted for an unauthorized term or use services or property of the Arizona Tactical Officers Association, in an amount of \$25,000 or more, entrusted to him or placed in his possession for a limited, authorized use, in violation of A.R.S. §§ 13-1802(A)(2), 13-1801, 13-701, 13-702, and 13-801.

COUNT 3:
THEFT

On or between May 9, 2016 and June 16, 2016, **JON PAUL MECK**, without lawful authority, knowingly obtained services or property of the Peoria Police Department, in an amount less than \$1,000, by means of any material misrepresentation with the intent to deprive the Peoria Police Department of such property or services, in violation of A.R.S. §§ 13-1802(A)(3), 13-1801, 13-701, 13-702, and 13-801.


COUNT 4:
THEFT

On or between June 28, 2016 and July 11, 2016, **JON PAUL MECK**, without lawful authority, knowingly obtained services or property of the Peoria Police Department, in an amount less than \$1,000, by means of any material misrepresentation with the intent to deprive the Peoria Police Department of such property or services, in violation of A.R.S. §§ 13-1802(A)(3), 13-1801, 13-701, 13-702, and 13-801.

COUNT 5:
THEFT


On or between July 1, 2016 and July 12, 2016, **JON PAUL MECK**, without lawful authority, knowingly obtained services or property of the Peoria Police Department, in an amount less than \$1,000, by means of any material misrepresentation with the intent to deprive the Peoria Police Department of such property or services, in violation of A.R.S. §§ 13-1802(A)(3), 13-1801, 13-701, 13-702, and 13-801.

Pursuant to A.R.S. § 21-425, the Grand Jurors find that the offenses described above were committed in Maricopa County, Arizona.


