I am pleased to notify you that the Arizona Attorney General's Office has reached a settlement in a lawsuit filed by the State of Arizona, Attorney General's Office against FCA US LLC, Fiat Chrysler Automobiles N.V., et al. ("Fiat Chrysler"). The settlement relates to the marketing, advertising, selling, and leasing of certain clean diesel ("EcoDiesel") vehicles for model years 2014-2016.

Records indicate that you may be an "Eligible Consumer" under the settlement. This means that you will need to attest that, on January 12, 2017, you owned or leased an affected 3.0-liter EcoDiesel vehicle that was registered with the Arizona Department of Transportation. Specifically, records indicate that you may have owned or leased a <<MODELYEAR>>, <<MAKE>>, <<VIN>> on the relevant date.

Please note that if you are represented by an attorney with regard to an issue with Fiat Chrysler, you should give this letter to your attorney and discuss this matter with him or her.

If you are an Eligible Consumer and you sign and return the enclosed Claim Form, you will receive a payment of up to \$1,000 under the settlement with my office. This payment is separate from any previous payment or payments you may have received from any other settlement relating to the Fiat Chrysler EcoDiesel vehicles. You may choose not to sign and return the enclosed Claim Form, but in that case, you will not receive a payment under this settlement.

To receive a payment under the settlement, you **must** sign and return the attached Claim Form to the Claims Administrator, Rust Consulting, Inc., at the address below. **Please note that by signing the Claim Form, you attest that you satisfy the definition of an Eligible Consumer under the settlement.** Your signed Claim Form must be returned to the Claims Administrator, Rust Consulting, Inc., postmarked no later than **November 13, 2019**.

Fiat Chrysler also has reached a nationwide, class action settlement (the "Class Action Settlement") with current owners and lessees and certain former owners and lessees of 2014-2016 Jeep Grand Cherokee and Ram 1500 3.0L EcoDiesel vehicles. That Class Action Settlement might entitle you to additional cash compensation and other benefits if you file a claim through the Class Action Settlement process, which is separate from the Arizona Attorney General's claims process for this settlement. The eligibility requirements of the Class Action Settlement include that the participant's vehicle must receive a software update to ensure compliance with the emissions standards to which the vehicle was originally certified without reducing advertised performance or average fuel economy.
