## Don't Roll the Dice with End of Life Care

Emergencies can happen to anyone at any time. If the unthinkable happens, who do you want making life or death decisions on your behalf? Advanced directives give you the power to choose someone in your life that you trust to make future health care decisions in the event you become unable to do so. Since we cannot predict the future it is imperative that all Arizonans complete the forms that will allow them to choose a representative as well as any treatments they do or do not want performed.

The Arizona Attorney General's Office provides free Life Care Planning packets, comprised of advanced directive forms for anyone in Arizona. These packets include a Medical Health Care Power of Attorney form, Mental Health Care Power of Attorney form, Living Will, Letter to My Representative, and a Prehospital Medical Care Directive (Do Not Resuscitate). Remove the burden from your loved ones and make your health care decisions now.
